Circumstances of each case can be heard and considered individually. Court costs are statutory with no court discretion. You are innocent until proven guilty by the State or until entering a guilty or no contest plea.

ATTENTION: If you fail to appear in court as required by law OR fail to satisfy a judgment ordering the payment of a fine and cost as ordered by the Court, you may be denied the renewal of your Driver License, Vehicle Registration and assessed an additional fee to secure compliance.

A PHONE CALL TO THE COURT DOES NOT SATISFY APPEARANCE.

A conviction of an offense under a traffic law of this state or a political subdivision of this state may result in the assessment on your driver's license of a surcharge under the Driver Responsibility Program.

1. I hereby enter a plea of _____ **GUILTY** _____ **NOLO CONTENDERE** and waive my right to a jury trial. A plea of Nolo Contendere means that you do not contest the State's charge(s) against you. This plea indicates that you agree to waive appearance before the court for trial. You may refer to the schedule on the reverse side to determine the amount of your fine(s). **MAKE REMITTANCE BY CASHIER'S CHECK OR MONEY ORDER** to the court address on reverse side. Return your copy of the citation and this letter with your remittance to assure proper credit.

2. I hereby enter a plea of **NOT GUILTY** and request a trial by _____ **JUDGE** or _____ **JURY**. If you request a trial you waive your rights to a Driving Safety Course.

3. You may be able to require that this charge be dismissed by successfully completing a driving safety course or a motorcycle operator training course. You will lose that right if, on or before your appearance date, you do not provide the court with notice of your request to take the course.

IF YOU HOLD A COMMERCIAL DRIVER LICENSE YOU CAN NOT TAKE A DRIVING SAFETY COURSE OR BE GRANTED DEFERRED DISPOSITION BY TEXAS LAW REGARDLESS OF VEHICLE TYPE DRIVEN AT THE TIME OF THE CITATION. YOU MUST HAVE A TEXAS DRIVERS LICENSE TO BE ELIGIBLE FOR DSC.

DRIVING SAFETY IS NOT ALLOWED FOR: SPEEDING 25 MILES OR MORE OVER THE SPEED LIMIT, PASSING A SCHOOL BUS, FAIL TO STOP/RETURN/REMAIN AT SCENE OF ACCIDENT, FAIL TO RENDER AID OR VIOLATIONS COMMITTED IN A CONSTRUCTION ZONE WHEN WORKERS ARE PRESENT.

_____ I hereby plead **NOLO CONTENDERE** to the attached moving violation and request that the court defer proceeding in my case for 90 days so that I may complete a driving safety course, present a Certificate of Completion, a certified copy of my driving record and have the court dismiss my case. I have not completed a Driving Safety Course within 12 months and I am not currently taking a Driving Safety Course. I further understand that this form **MUST** be signed, notarized and submitted to the Brookshire Municipal Court with the **\$114.00** cost, proof of insurance, a valid Texas drivers license and a self addressed, stamped envelope by the appearance date on my citation to be eligible for a Driving Safety Course.
